Directions: From the 401:Take the Waverly/Hwy 57 exit (Bowmanville). Continue north on Hwy 57 23.5 km to Devitts Road. Turn right (east) on Devitts and continue 4.9 km to Despairdale, 4471 Devitts Road. Farm will be on your left. Turn left through designated farm gate into handlers' parking area, in field west of house; entrance will be marked. Please close gate behind you if it is closed when you arrive.
